SUBJECT: ICS-162 (Technical Search and Rescue OSD) Implementation Plan

REQUESTED ACTION: The FIRESCOPE Technical Search & Rescue Subcommittee, Task Force, and Operations Team, respectively, request the FIRECOPE Board of Directors (BoD) to review and approve the updated implementation plan for the ICS- 162: Technical Search and Rescue Operating System Description (OSD).

Approval: This document was approved by the Board of Directors on February 5th, 2025.

SUMMARY

The FIRESCOPE BoD approved the ICS-162 (Technical Search & Rescue Incident Operating System Description) at the October 2022 meeting. Since its approval, through the ongoing process of review, minor revisions have been included in the document. Prior to the ICS-162 officially being published, an implementation plan document was developed and published with the "go live" date of July 2023. The implementation plan document details that by July of 2025, the new training and equipment standards in the new ICS-162 will be mandatory and all agencies will be held to that standard. Because the ICS-162 was not published until July of 2024, this Implementation Plan document reflects a timeline that is inaccurate. The Technical Search & Rescue Subcommittee proposes that the document be edited to reflect the actual publish date of the ICS-162 and update the dates to reflect the correct three-year implementation period.

IMPLEMENTATION PLAN

Phase 1: Technical Review and Publishing (October 2022 – June 2024)

Phase 1 includes technical review by the subcommittee and up through the FIRESCOPE organization until approved for publishing. Cal OES to notify regions and OAC's of the proposed "go-live" publish date.

Phase 2: Go Live (July 2024 – June 2026)

In Phase 2, the document is published to the FIRESCOPE website, and it becomes live in the system. Requirements for TS&R typed resources and personnel will be based on the OSD. Organizations will need to begin planning to make program implementation or adjustment plans based on this document and will be in a two-year ramp up period.

Phase 2 allows organizations to either make mid-year budget requests or to plan for approved budgets in the 2025-2026 fiscal year. The ICS-162 will also be separated by chapter and discipline to break up the document. The purpose of this will be to make editing the document much easier as changes come about.

Phase 3: Implementation (July 2026 – June 2027)

Phase 3 sees approved budgets and program adjustments, or implementations, based on the OSD.

Phase 4: Mandatory (July 2027 – Living Document)

Phase 4 sees the requirements in the OSD now being mandatory. Programs shall have MEL equipment caches, and training as outlined in the OSD. Any applicable CICCS qualifications shall follow the CICCS qualifications guide and timeline.
