# MUTUAL-AID IN ACTION OES Preposition

- Fiscal Year 2024/25:
  - There have been 209 preposition events approved: 140 for critical fire weather, 68 for mud and debris flow and 1 for Civil Unrest.
  - 80 moderate, 102 severe, 26 extreme, and 1 Potential Threat to Lives & Improved Property
  - The most requested preposition resource and most frequent user:
    - Region I has been approved for 56 prepositions. IMT members have been approved 535 times. LG Engines have been approved 822 times.





- 12 Deaths
- Reported Start 1/7/25 at 10:30 a.m.
- 23,707 Acres Burned
- 6,837 Structures Destroyed







### **INCIDENT**

- 17 Deaths
- Reported Start 1/7/25 at 6:18 p.m.
- 14,021 Acres Burned
- 9,418 Structures Destroyed





## MOSS LANDING BESS FIRE

#### **INCIDENT**

- January 16, 2025: Fire broke out at Moss Landing Energy Storage Facility in California, a major lithium-ion battery plant owned by Vistra Energy.
- Started in the 300-megawatt Phase I building, producing large flames and smoke.
- Evacuated 1,200–1,500 residents; Highway 1 closed; fire left to burn out due to lithium-ion battery risks.
- Subsided by January 17, with multiple subsequent flare ups including one reported on February 18.
- EPA found no immediate air quality threats; soil tests showed heavy metals near site.
- Fourth incident at facility since 2019; Monterey County declared a state of emergency on January 22.
- AB 303 introduced to improve safety regulations.
- Cause under investigation; recovery efforts began in late February.



FAST was developed and will be implemented as a modern, mobile application to optimize the California Fire Service and Rescue Emergency Mutual Aid System resource order filling and mobilization processes. The application will allow local fire agencies to provide real-time resource status updates while streamlining communication, improving coordination, and easing decision-making across the fire service to expedite all-hazard resources assignments and minimize losses to life and property.


