Second Annual Fire Operations Technology Summit

FIRESCOPE Co-Presented on January 22 and 23, 2020 at the two-day Fire Operations Technology Summit with the Cal Chiefs Operations Group, hosted by ESRI in Redlands California. It was a sold-out event displaying the strong cooperative effort between California's Fire Service and the IT Industry.

Executive Summary

The FIRESCOPE Board of Directors, Operations Team, Task Force and Specialist/Working Groups continue working to improve the efficiency and effectiveness of the California Fire Service consistent with the organization's mission. The California Office of Emergency Services (Cal OES) Fire and Rescue Services Advisory Committee / FIRESCOPE Board of Directors has approved and initiated new directives at their April 8th, 2020 conference call meeting.

The dissemination and implementation of new or revised policy, procedural and developmental documents is critical to maintaining the integrity and effective execution of Cal OES Fire and Rescue Branch operations, the Incident Command System (ICS), Multi-Agency Coordination System (MACS), and the State's Master Mutual Aid System. To that end, this "FIRESCOPE Quarterly Briefing" is designed to inform the California Fire Service and affected stakeholders of material changes, and to provide clarity as to the impact associated with new or recently revised FIRESCOPE documents.

FIRESCOPE Behavioral Health Working Group White Paper

The following white paper defines the roles and responsibilities for a Critical Incident Peer Support Team. This paper also recommends the formation of a new FIRESCOPE Behavioral Health Specialist Group. These peer support teams consist of trained firefighters, mental health professionals, chaplains, and canines. In recent years, federal, state, and local fire agencies have deployed peer support teams on critical events with success. Agencies have identified the need for a clearly defined process of baseline ordering, qualifications, and a clearly defined organizational structure for a team. FIRESCOPE Critical Incident Peer Support (CIPS) and OSD

The Critical Incident Peer Support Team (CIPS) is a team of highly respected, trusted, and qualified personnel assigned to a significant All-Hazard incident to support the mental health and welfare of the first responders engaged on an incident. This team is ordered by the Incident Commander (IC) or Incident Management Team (IMT) and reports directly the Liaison Officer or the Incident Commander at the IC's discretion. Team members are assembled at the time of request and shall be composed of qualified personnel to match the type of critical incident. A CIPS team consists of a Critical Incident Stress Lead (CISL), Critical Incident Stress Management (CISM) members, and Critical Incident Clinician (CICL). The CISL will assess the need for and reporting time necessary for the CICL and may or may not have Critical Incident Stress Chaplain(s) (CISC) or Critical Incident Stress K9(s) (CISK) as part of the team. The Cal OES Swiftwater / Flood Search and Rescue Working Group proposed updated qualifications and composition of Swiftwater / Flood Search and Rescue Teams in the California. The last guidelines were issued in 2001. The current updates were made to conform to national standards and ensure personnel are prepared to respond to swiftwater/flood search and rescue events. The changes include increased training, swim test, and peer evaluation. All proposals were unanimously support by the thirteen Cal OES Swiftwater / Flood Search and Rescue Teams. Team Staffing changes will be revisited at the July 2020 Board Meeting.

In order to comply with social distancing guidelines, the FIRESCOPE Board of Directors has cancelled all in person FIRESCOPE meetings through May 31st, 2020. This includes the upcoming Multi-Agency Coordination System (MACS) Exercises held annually in Redding and Riverside.
