

EXECUTIVE SUMMARY

The FIRESCOPE Board of Directors, Operations Teams, Task Force, and Specialist/Working Groups continue working to improve the efficiency and effectiveness of the California Fire Service consistent with the organization's mission. The California Office of Emergency Services (Cal OES) Fire and Rescue Services Advisory Committee / FIRESCOPE Board of Directors has approved and initiated new directives at their July 2021 meeting. The dissemination and implementation of new or revised policy, procedural, and developmental documents is critical to maintaining the integrity and effective execution of Cal OES Fire and Rescue Branch Operations, the Incident Command System (ICS), the Multi Agency Coordination System (MACS), and the State's Master Mutual Aid System. To that end, this "FIRESCOPE Quarterly Briefing" is designed to inform the California Fire Service and affected stakeholders of material changes and to provide clarity to the impact associated with new or recently revised FIRESCOPE documents.


FIRESCOPE Ops Team Elections

Fire Season

As the pandemic continues its impact on California's fire agencies, fire season is in full swing. After a record breaking 2020 fire season, we were optimistic and hopeful that the winter would bring wet weather leading to a moderation of fire activity in the coming year. Unfortunately, the precipitation did not come as hoped and now, all of California is under drought conditions and over 30% in exceptional drought.

Current fires since January are up over 200% of the 5-year average and acres burned over 250%. The mutual aid system is being utilized daily as California firefighters are again being called to demonstrate their dedication and resilience.

Northern and Southern California Seasonal Outlooks









July - October 2021 North Ops Highlights

- Very dry rainy season, weak snow melt runoff, and very low soil moisture.
- Dead fuels indices at or more extreme than peak season typical values with new records set. Live fuel moisture values below average.
- Low elevation fine fuel crop cured. Weak greenup underway above 4000'.
- Overall outlook is for drier and warmer than average through October. Near normal monsoon activity east, trending to less lightning than usual Coast Range.
- Significant Fire Potential Above Normal above 3000 ft elevations July-August, except along the coast and in eastern areas. Normal elsewhere.
- In Sept-Oct lower elevations W of the Cascade-Sierra crest join the Above Normal area due to critical dryness as offshore wind season begins.

July - October 2021 South Ops Highlights

- · Temperatures will be above normal through October.
- · Monsoonal showers and thunderstorms will be near normal July through September.
- · Rainfall will be below normal in October.
- · There will be a near normal amount of Santa Ana wind events in October.

FIRESCOPE Field Operations Guide: Since its first publication in 1983, the FIRESCOPE Field Operations Guide (FOG), has provided crucial information to first responders in an easily accessible format. All levels of FIRESCOPE have been working on an updated FOG with a planned release in January 2022. The 2022 FOG will be available in the booklet and as an updated mobile device application.



Behavioral Health Mnemonics White Paper: With FIRESCOPE creating the Behavioral Health Working Group and now the inception of the Specialist Group, they have been working to create industry standards for the recognition and proper utilization of behavioral health personnel and positions in the fire service. The Critical Incident Clinician (CICL), Critical Incident Stress Chaplain (CISC), and Critical Incident Stress K9 (CISK) have been approved by the Board of Directors to submit a request to the NWCG Position Naming Board for recognition and approval into IROC. FIRESCOPE Specialist / Working Group Reorganization: As the California fire service evolves, so must FIRESCOPE. The reorganization is based on the ethos established by FIRESCOPE.
