#### Task Force Update – Gerboth

# Task Force Report

- Board of Director's Meeting was held virtually on April 6th and 7th.
- Board of Director's expecting to have an in person meeting in July in Orange County.

# **Ops Team Meeting Update**

- CFAA has a new F42 letter size form.
- Regional meetings are upcoming.
- Continue UGS and resource availability. What is it going to look like for this year? Resources extending.
- EMAC request and how they are processed for out of state resources.
- Numbering system changing for OES apparatus. Four digit numbering system. First will be the region. Second will be the type. Then the engine number.
- The new OES Type I engines are being built with bigger cabs, 1,500 gpm pumps and 4" hose. They will remain Type III USR companies so they will remain outfitted with those.
- Discussed SB 209. Which established the Threat Integration Center.
   Staffing of the center. Working together with Cal Fire.
- OES assisting with vaccination sites.
- Fires have gone up due to the effects of the drought.
- Cal Fire is trying to hire additional crews. One of the major issues is that
  the pipeline is basically empty. Cal Fire is willing to take more crews out of
  the prison system and get them into the camps. With Covid and some of
  the new laws and trying to reduce head counts in prisons it's just getting to
  be a trickle of what we are getting out.
- Out of 168 inmate Type I crews in the state at full staffing, currently at 67. Twenty-one are less than twelve. 1,700 inmates down from typical

- numbers.
- Aircraft bases in Hemet/Ramona and Mc Clellan are open. To augment the crews, they are going to bring on 20 Firefighter I crews. Twenty paid crews and 12 CCC crews. All helicopters should be brought on early this year.
- Firefighter I & II curriculum are in retirement. New members starting January 1, 2022, are now going to take the testing required.
- Rescue class changes have been proposed. SFT is trying to find funding to upgrade the Rescue classes.
- Forestry and DOI funding has gone to remediation and prevention.
- FOG chapters 9, 14, 16, and 18 are still being reviewed and revised.
- The GIS Specialist Group Chair, Matt Marsh, did a presentation for the Ops Group. The presentation was about what the GIS group is working on.
- The Task Force approved the movement of Swiftwater staffing from 14 to 16 persons a year ago. As well as changes to the curriculum. The changes were approved by the Ops Team. The Board of Director's had some questions about changing the staffing from 14 to 16 on Type I Swiftwater Teams. It was supposed to be timed with the NIMS changes. NIMS put a hold on it due to Covid. The BoD approved the training and qualification changes. They tabled the staffing change. NIMS made the staffing changes last month. The BoD approved the staffing changes as well. Changes will be reflected in the FOG.
- Reviewed the FIRESCOPE Plan of Work, Charters and some of the Rosters. Discussed what some of the Specialist groups are doing.
- The 2020 MACS 441 Radio Communication Guidelines was approved by the BoD.
- Chief Hartwig gave an EMS update. The biggest topic was 201 rights. Who can provide exclusive use transport services?
- CFAA update was discussed. Forest Service was trying to pay on the local agreement not the CFAA. Two different reimbursement standards.
   Caused some issues with some of the local agreements. Working through it.
- The CWCG discussion was mostly about Incident Management Teams.
   They will staff ten Federal IMTs this year. The Incident Commanders have been selected. The CAG have been selected. Working through the Unit Leaders. Overall 20 percent less applications than last year. Struggling to put in some Unit Leaders.
- Chief Meston went over the Blue Ribbon Commission update. Surge capacity of the state, and the Type I/Type IIIs going into service were

- discussed.
- Private Fire Resources had a brief discussion. Qualifications and how they remain qualified. How we validate that.
- Chief Vale gave a CICCS update.
- Chief Marshall gave a FIRIS update. Gave an update on Cal OES Operations Bulletin I and the use of it.
- Next generation S.C.O.U.T. was discussed. Intent is to be operational by July 1.
- Chief Marshall brought up FIRESCOPE, Cal OES, Parallel Specialist Group discussion. Concerned with duplicating efforts. Funding streams. Insuring coordination between the groups.
- FEMA and EMI gave a presentation on NIMS and the All Hazard specific training.
- Next in person meeting is scheduled for June in San Francisco. Should be moving forward with in person meetings.

# Cal OES Update - Johnson

- Going into unified command with FEMA and other state agencies to help with the border migration issues.
- Fire Rescue is not being tasked. It is the Emergency Service Coordinators that will be the ones in the unified command. If they do mobilize any structure to that, it will be one of our Incident Support Teams.
- Members have inquired about changing the structure of the FIRESCOPE
  website. Would like to mirror NWCG's website with drop down options.
  Conversation with OES IT Webmaster regarding this. The software architecture
  that OES uses, doesn't allow for that type of navigation. The content
  management software is not the traditional sense of a webmaster for doing
  programing in that manner. We can restructure the website in other ways. We
  have the ability to add documents under each specialty group.

#### State Fire Training Report - Henning

- Things have slowed down due to funding and Covid restraints. Looking to put the cadre together in August.
- Firefighter I 2013 certification retires at the end of this year. Updated 2013 and 2019 certification: Experience and taskbook requirements have been removed.
- Firefighter II certification exam between now and the end of the year, no requirements to take a capstone exam through the state. After January 1, 2022, will be required to take the state certification exam.
- Firefighter II Tenured Path: Designed for the people who missed it when it was easier to get the Firefighter I certification. Only requirements are a certification taskbook plus the experience.

- Requirement for the old Legacy Chief Officer and the new Chief Fire Officer has been an associate's degree to get the certification. Working with CPF and the steering committee came up with a pathway for people who don't have an associate's degree but have college credit. Using a combination of experience and college credit. This retires at the end of 2022.
- Staff report with changes to rope rescue, retirement of rescue systems courses, and development of new structural collapse courses. Delaying the retirement of Rescue Systems I, II, and III.

#### OLD BUSINESS/PROJECTS

#### FOG ICS 420.1 2022 Revision/Review - Johnson

- Currently at the BoD level.
- Chapters 9, 14, 16, and 18 have all been approved pending edits. Edits have been completed on all chapters excluding 18.
- · Agreed to add both Planning Ps.
- Working on getting the FOG into the right format for printing. The goal is to have everything done by June 1 to give back to the groups in a draft print version.
   Waiting on State Finance to approve moving forward with the print vendors.

# Standard Wildland Preplan Working Group - Capobianco

- Moving forward.
- Asked for an additional month to do a presentation. Agree on symbology and content. Basic map and how to deliver it. Putting together some options on Common Operating Platforms. Will give a 5 minute presentation at next meeting.

## **ICS 215C Contingency Form – Spelman**

- Form has been worked on for a couple of years. This form is bringing on a contingency element.
- A survey was put together for feedback. Received positive feedback.
- Would like to get the form pushed up through the FIRESCOPE process.
- Currently in draft form and feel that people are hesitant to use it because it is in draft form. Would like to be able to remove that.
- Bring back in May for approval. Ops Team in June and BoD in July.

# **DECON Unit Typing Project** – Stinnett

- Met a couple of weeks ago. Created a sub-committee. Lots of discussions taking place.
- Typing is going to be challenging. Is number of personnel going to be a factor?
   Types of contamination? Differentiating the different types.
- Looking at many sources for information.
- Guidelines being looked at. State and federal.

- Made contact with Civil Support Teams.
- Timeline is a minimum of 6 months.

# **UAS Training** – Huff

- Next direction is creating a working group and move down some of the inoperability and resource sharing statewide.
