  - Review and discussion of the 2023 FIRESCOPE POW.
- \*MACS 410-4 By-Laws Review Johnstone/Kendall/O'Brien/Gerboth
  - Review and discussion of the updated by-laws.
- \*SB 450 Background/Review/Intent Walder
  - o Passed and went into effect January 1, 2023.
  - o Part of Proposition 19. Approved in 2020.
  - Implements the fire prevention and response funding portion of proposition 19.
  - Requires that OES administer the Special District Response Fund.
  - Cal OES with the FIRESCOPE BoD will:
    - Develop a standard application form.
    - Establish an annual timeline to apply for grants.
    - Employ strategies to ensure that underfunded special districts that provide fire protection services are aware of the availability of the fund.
    - Establish reporting requirements for grant recipients.
    - Develop metrics for consideration of grant applications, as specified.
  - o Right now, there is no application or funding. Every year on June 30<sup>th</sup> the Department of Finance will project the proposition 19 money that will go into the fund.

## CICCS & Complex Incident Management Team Update – Vail

- Had a meeting yesterday with NWCG.
- o Wiped out the pathway for Type II teams. Conflicts with CICCS.
- Had a CICCS Task Force meeting January 18<sup>th</sup> to begin the rewrite of the 2022 version that was just approved.
- o CIM is moving faster than we can keep up. Still looking at 2024.
- Type I and Type II will remain in IROC for a while. We aren't changing any of our Emergency Management positions.
- o CIM rotation starting in 2024. Will stay the same as it is this year.
- CAL FIRE and FEMA aren't changing their qualification systems.
- Will probably discuss this at the BoD in February.
- o Waiting on some significant documents to come out from NWCG.

  - o New Director, Nancy Ward.
  - New Northern Operations Chief, Sam Marouk.
  - New Fire & Rescue ESF 4, State Operations Center, OES AC Rob Scott
  - OES Appreciates all the agencies that helped with the recent floods. Record number of prepositions.
- Cal Fire Kendall
  - Staff working on the budget.
  - o Continuing focus on fuels work up and down the state.
  - A lot of focus has been put on the Fire Hazard Severity Zone and the public comments. Process is ongoing.
  - Busy the last two weeks with mission tasks. A lot of work went into supporting local governments.
  - o Predicting a very busy fire season due to all the rain.
- USFS/DOI Skelton/Goss

#### USFS

- Announced last week the Wildfire Crisis Strategy adding an additional two landscapes in California. That's a total seven priority landscapes. The regions are looking into how to approach those priority landscapes. Hopefully in an interagency manner.
- Looking to build capacity in fuels program across the 18 forests in California.
- o No change in aircraft from last year.
- Resource wise, had two in person hiring events this week. Waiting to hear what the numbers look like.
- Hot shot crews may have some fluctuation between Type I to Type II IA based on hiring.
- South Ops cache is understaffed. Lack of labor workers.
- Randy Skelton announced his retirement last week for February 24, 2023.

#### DOI

- New BLM State Fire Director, Peter Kelly from Fish & Wildlife. He and Scott Lucas are transitioning. Scott Lucas will be retiring at the end of February.
- Working on the re-classification of Technician Wildland Firefighting series.
- Work continues regarding the long term plan for Firefighter pay.
   Funding runs out September of this year for the retention bonuses.
- Lots of work being done on the Type III pathways. Trying to bridge the gap to CIM.
- Will share a link regarding what NWCG is doing on the multiple pathway conversions.
- Inflation Reduction Act new funding source.

#### **NPS**

- o Small workforce.
- o Finding ways to best place assets, equipment, and personnel.
- Have vacancies like other federal partners. Looking at locations that they haven't been able to recruit in.
- o Regional Office vacancy for Regional Aviation Manager.
- State Fire Training Petty
  - o Chief Richwine retired at the end of last year. Daniel Berlant is filling in until a replacement is found.
  - With the promotion of Andrew Henning. There is a vacancy for Division Chief of State Fire Training. Hoping to have it filled in spring.
  - o Retirement of the Rescue System Series.
  - Rope Rescue Awareness and Operations/Rope Rescue Technician will replace them.
  - New Structural Collapse Specialist I & II courses.
  - o Changes made to reflect the rest of the nation. If sent out of state.
  - o Going through Pro Board Reaccreditation in spring of this year.
  - Will be some changes to the Firefighter's curriculum.
  - View the website to be aware of any changes.
  - New training to go through STEAC. Home Ignitions and Defensible Space curriculum based on AB 38.
  - Maritime Firefighting for the Land Based Firefighter will be heard at State Board Fire Services next month. Goes live March 2023.
  - Incident Safety for the Agricultural Land and Lifestyle Producers will also be heard at State Board of Fire Services. Goes live March 2023.
  - STEAC meeting for first read of Firefighter Survival and Firefighter Rescue and RIC Operations was this month. Go live is May 2023.
  - o Receiving many Curriculum proposals.
