Task Force Update – Gerboth

- The Board of Director's meeting took place on July 7-8, 2021.
- First day focused on updates and a Wildland Pre-fire presentation delivered by Mike Scott.
- Forest Service is having issues with retention and recruitment.
- Inmate crews are being reduced. Trying to obtain more people to be on Firefighter I crews. Transitional position. Do have Type II IA crews for the units.
 Will be difficult to meet the needs of all the firefighters this year. A lot of transition going on.
- Presentation given on marijuana cultivation. The dangers and hazardous materials surrounding it. Guidelines are needed.
- Chief Richardson's departure and the Ops Team elections.
- Discussion of the FOG. 50th year anniversary.
- The updated Quarterly Briefing was approved by the BoD.
- Discussed the Behavioral Health White Paper. BoD was supportive.
- Specialist group reorganization was approved by the BoD.
- The ICS 215C was presented to the BoD and approved. Working on a fillable form for the document. Recommended that a letter from the BoD chair be shared with the teams stating that the form is now available once it is completed.
- REMS working group has reconvened. Charter, roster and POW were completed and approved.
- The MACS Exercise video was viewed and approved at the BoD meeting.
- Recognized the members of OCFA and the Riverside unit. Letters will be sent out.
- All of the products that were pushed up to the BoD were approved.
- CFAA update included discussion regarding some of the logistical challenges with the federal incidents that are happening. Having struggles with getting regular services. Agencies are going to have to become more self-reliant. Would

like to have these issues handled at the lowest level possible. Talk to your OES rep. They are there to assist with any problems.

- Chief Fennessy and Chief Meston discussed the Blue Ribbon Commission.
- Discussion on private fire resources.
- Everyone is welcome to attend the BoD meetings either in person or virtually.
- Chief Vail gave a CICCS update. They are going to start reaching out to the regions. Going to do some regional meetings.
- FIRIS 3.0 should be coming online by the end of the month. Right now, FIRIS isn't operating. FIRIS 3.0 will have two platforms, one up north and one in the south.
- Discussed next generation S.C.O.U.T. Working with a vendor.
- Presentation on Incident Workforce Development Group. Main focus is complex incident management.
- Presentation on resource tracking. Integrated with Blue Force. A lot of different avenues out there.
- Went over most of the specialist groups at the BoD meeting.

Cal OES Update - Johnstone

- Polo shirts are available to order. The information is located on Smartsheet.
 Orders can be delivered or picked up in Riverside. Link will be shared with members of the Task Force, Ops Team and BoD. Chief Spelman offered to pick up orders.
- OES has close to 35 strike teams or task forces out right now. Plenty of surge available but the fire season has started. Having mechanical issues with some OES Type VIs. Four strike teams in Oregon from California.
- Received an 18% increase in the budget and 229 positions. Did not get a
 position for an Assistant Chief for FIRESCOPE at South Ops.

FOG ICS 420.1 2022 – Johnson, Cathy

- In the final stages of editing the chapters.
- Starting to get the wire charts back from State Publishing.
- Goal is to send it to print at the end of the month.
- Working with the IT department on the cover logo.
- Contract went out for 15,000 FOGs and an assessment in 2.5 years if more are needed or pushing efforts toward the app.
- Considering a price increase. May include a challenge coin with purchase.
- FEMA has a "What's New" section in the front of their document. Considering

- doing the same with the FOG.
- May be the last printing of the FOG. Possibly using only, the app in the future.
- The FOG doesn't have a printable version. It was copyrighted in 2014. Will check into seeing if we can make a pdf version that is printable again.

- Had a presentation at the Ops meeting in San Francisco given by the Forest Service UAS Manager for Region VI. Have made significant advancements in the training curriculum. Working hand in hand with Cal Fire.

- Working through the new qualification guide. Getting it finalized. Looking at fall for completion.
- Chief Vail is going to reach out to the regions and have them give a presentation on the changes.

- Received approval from the BoD to move forward.
- Implementation by the end of the calendar year is expected.
- Some documents need to be changed.
- Documents to be completed by the next BoD meeting.
- Reviewed the updates to the reorganization.
- Chief Marshall had a couple of changes that he would like to see.
- Will schedule a Teams meeting for all of the chairs at the August Task Force meeting in San Diego.

NEW BUSINESS/PROJECTS

Pilot Helicopter Carding – All

- Tasking from the BoD.
- Reviewed and discussed the document.
- Things have changed significantly over the last 30 years.
- The qualifications are considerable. The aircrafts have changed.
- They fly 24/7. All hazard missions.
- For night flying they are getting carded with Cal Fire and Forest Service policies.
- Some of the items on the inspections are not applicable.
- Most of it is legacy documents. Starting to work through those.
- The intent of the BoD was to give it to the Aviation Operations Specialist Group and have them start to look into it. Report back in October.

HELCO - All

- Is there a workaround for not using HELCO operators?
- Bridging the gap.
- Many operators are not HELCO qualified.
- Does the name need to change?
- Operators thinking that they are HELCO when they aren't.
- Taking on a lot of liability.
- Do we need more HELCOs? Do we need a training program developed?
- Report from Aviation at the Task Force Meeting in September.

Marijuana cultivation Safety Guidelines – All

- Will see if the Safety group will take this on.
- Will send out the PowerPoint presentation to everyone.
- Many hazardous materials are used in the cultivation of marijuana. Some that were banned decades ago.
- Discussed other challenges such as methamphetamine production and homeless

encampments.

EIT, Blue Force, Tracking – Spelman

- Will have the Forest Service reach out to Blue Force.
- Will contact EIT and see what they want to do with it.

Safety Specialist Group Discussion – Don Reyes, Vice-Chair

- Discussed the verbiage in the TRA, Tactical and the Mayday that the Safety Specialist Group has a concern with.
- The TRA issue is what advantage does this name change bring?
- Is there an operational advantage, ICS or something strategic that they don't see?
- They feel that the language that is used now is working. What is the reason for the change or additions?
- Decision from the Board of Director's was explained by Chief Johnstone.
