- TF discussion on how clinicians are ordered to an incident and how they are paid
- Several suggestions made to edit current White Paper in regard to full implementation plan and how project is implemented
- Updated PowerPoint will be presented to Ops Team

CAD to CAD Interoperability (Spelman)

- May 22nd meeting to discuss
- Chief Gardner attended meeting and summarized that CAD to CAD is only a piece to solve problem and added more layers
- EIT Chair developing document that had detailed notes from meeting and potential steps to take

Resource Typing Decontamination Unit and Rehab Unit (Tomaselli/Enos)

- SART draft and Resource typing draft in progress
- June 18th deadline

Standard Wildland Preplan (Heggstrom)

- New format is partially based on the ICS209 form
- Risk assessment matrix is still in development
- DRAFT presented to TF- 6 pages long
- Suggestion to add staging location
- Suggestion to have pre-plan filled out as a sample when presented to Ops team
- Concern about potential plagiarism from original Rohde document
- Suggestion to have Hazard mitigation funds be used to develop a statewide standardized preplan that is accessible to everyone. Standardization is important. Johnstone will bring idea to Chief Marshall. Could be further leverage to make SCOUT more relevant statewide

SCOUT Procedural Manual (Spelman)

- Next meeting on June 12th with EIT group
- Framework of SCOUT is constantly changing making it difficult to finalize project
- Situational awareness survey is in progress and will enlighten current situation with SCOUT

- Caroline Jacobs is no longer working on SCOUT project
- Suggestion to hold further work on project until survey results are complete. Projected completion date is now December 2019

FIRESCOPE Website Redesign Update (Johnson)

- Discuss specialist groups document prioritization and archive process. Needed introduction language for tabs on home page.
- Johnson gave briefing on history of website migration project and objectives behind it
- Johnson presented current version of the FIRESCOPE website design
- Discussion regarding how documents are listed on the website (Name vs. ICS number)
- Several suggestions from TF on how to organize documents on website and how website should look
- Old website will not be accessible after July 1st, 2019.
- List of all downloadable documents on old website have been sent to the contractor for ADA conversion
- All SG documents on each SG page have been pulled off website and have been archived on Smartsheet and need to be ADA converted.
- SG's need to look at older documents that might require updates and ADA conversion. Need to prioritize and place in the POW as well as forward to Kelly ASAP, no later than June 24th in order to send to contractor for ADA conversion
- Documents need to be updated with new South Ops address
- Suggestion to look at analytics of website use at least quarterly for ultimate reporting to the BoD

Evacuation/Repopulation and LELO WG (Johnstone)

- Review terminology document in SmartSheet with Task Force
- Agreed upon terms being proposed:
 - o Evacuation order
 - Evacuation warning
 - o Shelter in Place
- Further discussion needs to occur with statewide law enforcement partners regarding these proposed terms

Joint CWCG and FIRESCOPE Fatigue Memo (Tomaselli)

- Joint memo presented and reviewed by TF
- When memo is released it will be posted on FIRESCOPE website
- It will need to be ADA compliant before posting

Channel Load Survey (Kuempel)

- Final review with Task Force prior to presentation to Ops Team
- 10-minute presentation planned
- Overview of statistics from survey will be presented
- Channel requirements reside in CFAA document

Aviation Air to Ground Communications White Paper (Enos)

- Removed from Ops Team Packet pending further review by USFS and CAL FIRE. Woody, Brook and James to provide update
- Mike Eaton was consulted and he felt that USFS and CALFire need to work out differences first before moving forward
- In the meantime, it will be operations as usual on incidents
- Kelly will make sure that Enos is updated on current status

Mud and Debris White Paper (Gerboth)

- Mud and Debris Flow PrePo Group meeting May 21-22 will gather information for updating white paper.
- Chief Marshall arrived on second day
- Intent is to redefine pre-position guidelines on mud and debris flow and put science behind the guidelines more than just rain amount totals per hour
- Bringing in National Weather Service, USGS, and predictive services as a consultant
- Reviewed objectives for group
- Huff is the secretary
- Conference call scheduled in June
- White Paper itself is on hold for now
- Deadline for completion is October 2019

- Editing will be completed by Kevin Hansen (ORC) so footage can be posted on website. Proposed draft video to be completed by August with final to be approved in September. Will be reviewed by Ops Team.

FIRESCOPE Vehicle Stickers (Johnstone)

- Kelly to discuss at July BoD as part of marketing and messaging. Cost \$9.00. Work with Jim on purchasing process for agencies
- Cal OES can't sell stickers to agencies that are interested, but can provide them if agencies are interested
- Suggestion to bring awareness to Chief Officers on the BoD regarding the ability to obtain FIRESCOPE vehicle stickers

ICS 215C Contingency Form (Barnett)

- Brook forwarded document to CAL FIRE IMT Ops Team. Brook to bring back at May meeting. Brook to check with Dave on doing presentation for CAL FIRE.
- Contacted all CAL FIRE IMT Ops Chiefs and waiting for responses and comments

 - o Focus is an all hazard approach
- Replace aerial terminology with aircraft in all documents
- Concerns with creating FIRESCOPE branded task book that might not be universally accepted when it is essentially the same as an NWCG task book.
- In order for training and qualifications to be accepted nationally, then it needs to be accepted by NWCG and any course equivalencies need to be adopted and approved. Otherwise personnel will not be able to leave California and not entered into ROSS.
- Recommendation is to use current course plan, NWCG task book and then determine course equivalencies. CICCS needs to be consulted as well. Henning will be consulted
- Job course aid's can be added to NWCG task book if anything is missing that CA or the TF requires

Use of Non-Public Radios on Incidents (Lucas)

- Scott Lucas to discuss with Comms Group to identify issue and have them develop white paper as necessary. Will discuss during next Comm's Group meeting
- Focus of discussion at Comm Groups Meeting was: Why is this happening and what is the issue?
 - Not enough frequencies
 - o Radios are handy
- White Paper is currently being drafted to detail issues
