Subcommittee and Specialist Group Status Update Reports

Old Business

- Mutual Aid for Prescribed Wildfire at Scale White Paper Brown
 - Communities continue to be at risk.
 - Need for a system that does both preparation and response.
 - Task Force discussed this at their meeting yesterday.
 - Asking to get the concept out there.
 - Ops Team discussed.
- Urban Conflagration Training Update Serrano
 - Urban conflagration fires are increasing and becoming more regular.
 - Firefighters may not have any previous training or experience.
 - Currently there is no formal training.
 - Development of a training curriculum that emphasizes preparedness is necessary.
 - Presented the issue of training to STEAC.
 - Training could be incorporated into FF1 Curriculum as a stand-alone class, and/or included as an additional module(s) of existing ICS training.
 - Document was created for awareness. It will be shared with the Ops Team.
 - Chief Meston requested a presentation at the Cal Chief's Annual Conference.
- FIRESCOPE FOG App Update & Discussion of Plan for Future FOG App Revisions – Johnson/Johnstone
 - No more FOGs will be printed.
 - Revamping the app. May need more funding.
 - Ability to build in chapters.
 - Adding Wildland Fire, Structure Fire chapters and all the associated documents.
 - Drop down lists of all of the documents available on the website.
 - Will be more user friendly.
 - Will share the FOG White Paper at the September Ops Team meeting.
 - Adding subcommittee chapters and document links.
 - Chief Johnstone asked for members to contact him about other apps that are user friendly that can be mirrored

- o FIRESCOPE Mutual Aid Coordination Team Update Walder
 - MACT is still going strong. Just taking a backseat to the executive order work group right now. Lots of work to be done.
 - All day meeting next week. South Ops.
 - Also see the update under New Business.
- Update on Lithium-Ion Subcommittee Name Change and EV Hazards – Rezende/Taylor
 - Possible expansion of their scope to be able to address a broader range of issues.
 - Request that the subcommittee become permanent vs ad hoc.
 - Looking at the challenges of alternative fuel.
 - Will be working on a White Paper and will bring it to the BoD in October.

New Business

- Update on Fire Resource Ordering Process Workgroup McGovern/Walder/Cook
 - Honest and courageous conversations putting everything on the table
 - Making good progress.
 - Working through many comments and the process.
 - Being very transparent on challenges.
 - Survey was sent out. Receiving great feedback.
 - Looking at one or two recommendations by July 1st that can be implemented in the short term.
 - Getting immediate resources out quicker.
 - Three or four phases that Jackie Williams and Lori Lopez have set. Currently in phase one.
 - Ops Bulletin One discussion.
 - Master Mutual Aid discussion.

Updates and Reports

- Cal OES Johnstone
 - Discussed with the Task Force yesterday. Proud of all the work that FIRESCOPE does at all levels. Thankful for everyone's effort.
 - Conversations are respectful while dealing with tough issues.
 - Encourages FIRESCOPE to continue doing that.

Importance of coordination with the BoD.

CAL FIRE

- At peak staffing as of March 15th.
- 66-hour work week implemented. Work 9 months a year statewide. March 15 through December 15.
- Moving to implement traditional staffing. Fire captain, fire apparatus engineer and a firefighter on each piece of equipment. Over the course of a four-to-five-year period.
- As of June 1st, all CAL FIRE helicopter bases are now staffed with Type 1 Firehawks. Having trouble getting reserves into place.
- Two C-130's currently staffed.
- Prescribed fires are a big focus. Accomplished 50,000 black acres across the state.

USFS/DOI – Ahearn/Brinsfield

- Resources similar to last year.
- Just completed a hiring round.
- Hotshot crews 45 to 46.
- Working on the Fed side of aggressive rapid mobilization.
- Document on the South Ops website. Lists every available
 Federal piece of equipment in the state.
- Working with CAL FIRE and Cal OES on closest source mobilization.
- The President recently signed an executive order on the federal agencies brining fire programs together.
- Discussed 2026 budget. October 1st.
- Major changes coming. A lot of it could be positive.

Office of State Fire Training – Henning

- Hosting a Battery Energy Storage Systems Fire Safety Symposium on July 24th in Nashville from 8am-5pm.
 Registration on their website.
- New 2025 codes were approved by the Building Standards Commission. Will be published on or before July 1st. Implemented January 1, 2026.
- Working on future code changes.
- Discussed 2025 Training.
- Setting up a new wildfire prevention grant solicitation to be launched in the next couple weeks.
- Large firework seizure in Commerce going into Memorial Day weekend. Filled up all the capacity in Southern California to accept seized fireworks.

- DOI Brinsfield
 - Just finished up with the National Fire Preparedness Review.
 - Currently five-day staffing with seven-day coverage in the station, with the engines spread out.
 - Two helicopters in Apple Valley.
 - Working on filling vacancies quickly.
 - Looking upbeat this year. Fully staffed crews. Strongest in a while. Diamond Mountain and Primm Valley will not get their status this year.
- o NWCG NIMS Integration Committee Gerboth
 - Looking at some reorganization.
 - New chair, first meeting next Tuesday.
 - Chief Gerboth is staying on as the Vice-Chair.
 - Complexity analyses discussed in the last meeting put on hold until we see what the path forward looks like.
- o NFPA Neamy
 - No report
