Not much work from the TF, anticipate the structure defense coming back to this group for final review, will be coming from the wildland group. TF confirmed that this group will not be tasked with curriculum development, that belongs to another group in SFT. - Additional dialog about high rise response across the agencies and the different response plans:
 - San Diego: Goal of getting 100 bodies on scene within 20 minutes
 - La City 36 bodies within 5 minutes then incremental request based on need
 - La County 36 bodies initially then alarm as requested
 - San Bernadino 100 bodies within 30 minutes, High High-Rise Response triggers Auto Aid from Riverside to cover city
 - SF Initially 38 bodies then 23 to follow

Roundtable

- Price question if each agency has a policy on FIRESCOPE participation? No agencies with policies, chiefs support. FFD added squads, hired 80 over the past 12 months
- Henery– OCFA, ambulance issues with status 0, 35–45-minute waits for boxes. Issues with local EMSA and shoot times, new operations chief starting soon. Looking at FIREHAWKS after Emerald Bay fire.
- Tomlinson New fire chief Chief Crowley, change of personnel in administration, projections for upcoming budgets show the city in the hole, encampment fires extending into structures is a problem. Dialog about E-Engine going into service in Hollywood soon.
- Ghorbani 100-year celebration next year, impacted by ambulance shoot times, using the AP units having a good impact – going to 4 units. Staffing is an ongoing issue, promotions and hiring is struggling to keep up with demand. Looking at expanding paramedic assessment units to bring call volume down per rig. 8-10 recruit classes this year.
- Sanchez Promotion April 4th, Support Services Division Chief, academy in progress, All stations in SB County will be ALS by July 1, first female BC starting this week, dialog about MQ's for promotions, impacted by a young agency as the need for promotions increase. Going to tablet command in April.
- Tracy Ops Chief is retiring, currently have an interim, lots of personnel movement, academy on going, graduates in June 60 new hires in the past 6 months, looking to fly lateral positions targeting members released for VAC status. 4 stations being rebuilt, 2 new stations being built will result in adding a battalion in Fontana, looking at providing service for Running Springs, adding companies (SAFER Grant – 16 bodies)

in high desert divisions

- Liversedge Staffing issues on going, just stopped brown outs, brought administrative personnel back out to the field to help with staffing, just graduated an academy, changed training staff schedules to have dedicated training officers, running 6th engineer exam in 3 years, struggling to get enough qualified members to take the test, Prob B passed, changes in the retirement system coming. Ops chief retiring this year, 3 new stations coming in this year, looking at running peak engines – 12-hour shifts, wildland prep starting for the season, FIREHAWK in service with nightflying.
- Rabbitt Staffing down by 300, mandos are on the drop, new Lt academy starting in May, 18 members separated for Vaccination status, 15 retired early, encountering fentanyl OD's more and more, issues with status 0 ambulances, looking to increase staffing in ambulance division, high sick leave usage, looking to institute a wellness program please provide info if you have one. New fire boat station open, floating barge replacing a 105-year-old station.
