Agenda Item/Minutes:

Chair Cary Eckard called the meeting to order at 0930.

2. Chair Eckard announced that he retired on 1/12.

He conducted the election for his replacement on the Southern Operations Team. Steve Vittum was nominated, and elected unanimously.

The JOT voted to have Steve Vittum to fill the remaining year as their Chair (2002 - 2003). Steve Vittum assumed the role as JOT Chair. Cary Eckard thanked the members of the JOT for their professionalism and cooperation during his tenure as Chair. He was applauded for his service to FIRESCOPE and the JOT, and was wished a long and happy retirement.

3. <u>Discussion:</u> Members commented the IMS liaison will be a welcome addition to the JOT. This will enhance our image with IMS, and will improve our communication with the fire service in the United States. This resulted from direction from the FIRESCOPE Chair, P. Michael Freeman, LAC, after he attended an IMS meeting. Chief Freeman wants the fire service to know that we are open to input from those outside California. Bob Neamy explained the history and relationship of IMS and ICS (FIRESCOPE). The "Decision Model" and how to make it more effective were discussed. Mike Colgan, IMS Chair, gave an overview of these issues. Discussion continued. George Maier responded that the perception that FIRESCOPE is a closed system in incorrect, and as the "keeper of the keys" we have an obligation to insure the system remains intact. Since FEMA, NFA, USCG and others have adopted ICS this becomes more important.

The BOD directed Geoff Wilford, KRN, to attend the meetings until a replacement could be identified. Members of the JOT were asked to provide potential candidates for this position. Discussion on the position, qualifications, etc. continued. The qualifications of four candidates were discussed:

All agreed that each of these candidates were well qualified for this position. Discussion on specific issues relating to NWCG, Working Teams, travel, per diem, etc.

Bob Neamy: Discussion on Area Command, I 400, Module 15.

LFD application of Area Command explained. Bob expressed concern that the language in Module 15 (and other places) needs to be clearer: i.e., the role of the EOC, ACOM, and IC's should be explained. Reporting relationships must be made clear. Recommend language changes.

10. National ICS 209 Project: Bill Plough (w/handout)

Bill demonstrated the current 209 via modem www.famweb.nwcg.gov He reported on the progress of the national 209 Beta Test during 2001, and the changes expected for this (2002) fire season. He discussed all aspects of using the program, giving detailed information on use, pull down menus, types of reports, USF support, reporting capabilities, etc. The program will go on line nationwide in March 2002. Discussion followed Q & A.

Discussion: USF: new versions of electronic ICS 209 will focus on "all risk"; to include hazmat, US&R, structure, and earthquake. Incident type will trigger resource list.
