### **June 8, 2016**

- **Call to order: 0800 by Reyes (LFD Vice Chair)**

The Safety Specialist Group was greeted by host, LaVogue (BDC)

**Welcome, Introductions, and Logistics:** Reyes (LFD Vice Chair) and LaVogue(BDC)

**Agenda Review:** (All)

**Task Force Summary Report:** (Woody/SBC Task Force Liaison)

- New person assigned to TF Tim Kelly (LFD) will be replacing Butler and Mark Hafner (CalFire)
- 2016 FOG still being worked on.
- FIRESCOPE app discussion being free
- AH330 Strike Team Leader curriculum updated (new roll out) State fire training
- Aviation group working on standardized hoist operations
- Work towards a common IT platform amongst all agencies to cross share information.
- Discussion on the app California Common Operational Picture (Cal-COP).
- **TF update Fraley conference call** with Klusyk also on to provide updates as the Chair.
  - TF has had 2 meetings and the discussion regarding the MACS activation was a subject matter.
  - Cal-OES has 2 vacancies, 1, special ops, 2, FIRESCOPE. They are also adding a division chief to some regions.

- FOG revision, hit a significant bump. It is 90% complete but it still has work to be done and the person assigned is no longer completing the project. Will not be completed by July 2016 like hoped for.
- 2 REMS comments from Safety Summit were not helpful.
- Fireline EMT/P curriculum completed
- ICS 215-A has been sent to EIT for a “fillable” document.
- Firefighter suicide was a topic of discussion and should be a topic to be re-addressed in the future.

**Old Business:**

- Health and Hazard Database (Pisciotta)
  - Smoke White paper changed names to the “Health and Hazard Database”. This provides a wider coverage of safety and health issues being covered including the smoke exposure issues.
  - Mary Valance and Brian Bulger assisted in reviewing the information and provided excellent feedback.
  - The paper as it sits today is 100% ready to be sent to the Task Force for approval to be sent through the chair to the Board of Directors.
  - The website needs to be adjusted and added buttons on both home page and safety specialist section to hold the resources that will be gathered and review twice a year.
  - Updated resources shall be included and deleted within the website as they are collected. This “One-stop-Shop” idea will provide and firefighter with key information regarding exposures and health related issues.
  - A motion by Sanchez to accept the document and send forward. Reyes seconded the motion and approved unanimously.

  - Mike reinforced all of the work completed on the Health and Hazards Database and supported the motion to move forward.
  
- Don Reyes (Active shooter incident UCLA)
  - Don reviewed the incident and the operational challenges and achievements.
  - TEMS Draft position paper. 3 signatory papers then to Operations.

  - SART reports can open up issues with litigation and with the Cortland report brought other raised problems.
  - The consensus is that this subject matter should be sent back to Operations for clarification and to address potential issues. It was also discussed that this should potential start with green sheets, blue sheets then SARTs.
