#### MAC EXERCISE

The next Task Force meeting is scheduled for the afternoon of May 21 and May 22. The MAC's Exercise will be May 23, 2002 in Riverside. The MAC's Orientation is scheduled to be in Redding, June 13, 2002, with the Task Force meeting June 11 & 12, 2002. There will also be a barbeque at South Ops on the 23 of May, for a cost of \$7.00 per person.

This exercise will help the personnel who are new to your agencies to become acquainted with the MAC's process. In light of all the recent retirements, it is important to get the replacement personnel trained.

#### What is the MACS Exercise?

We bring representatives that would come to the MACS room during a Mode 4 fire siege. The bulk of the representatives would come from all the fire agencies (State, Federal, County & City). The thought is during a Mode 4, these people show up with OES, CDF and the OCC staff coordinating the distribution of resources based on the



type of need. The fires they are working are listed, and distribution of resources is made based on information received from each participating area. The incidents are prioritized for the OCC to fill resources. The Task Force members are facilitators of the training for the people who would respond in case of a MACS 4 Mode situation.

The following forms used in the MACS Exercise were reviewed: MACS 400-3 Resource Designation System Forms Packet, MACS 410-1 MACS Procedures Guide and MACS 404 Agency Assessment Briefing Form.

Agency Assessment Briefing Forms MACS 404 - MACS Mode 3-4, is a general intelligence gathering form. Form 425 – gives some feel of what each agency has committed. Form 429 – The Incident Priority Matrix is one of the most important forms because it a way to set priorities, a process of scoring incidents. The process is carried out twice a day.

## HOMELAND PROTECTION - BILL PLOUGH

John Kimble has been tasked to set up response to terrorism, disaster, etc., program nationally. Need to ensure that we are not left out of this process. LA City has somebody already detailed to Washington for their input. We need someone from at least the OP's Team level to be in touch with what is going on with the process as it progresses. P. Michael Freeman's name was given to John Kimble, but we are not sure if he has been contacted. Crime scene when there is a bombing.

Jim Wright asked Bill Plough to be a representative for CDF at the IMS Consortium. This adds another Task Force voice to the process. The next meeting is in November 2002.

#### Action:

Need to get a letter to Chief Zagaris asking him to bring this to the attention of P. Michael Freeman regarding the Federal Terrorism Preparedness Programs/National Defense being headed by John Kimble.

WIRE CHARTS OUT MGI-

FIRE LINE EMT- Steve Back online, should have a rough draft ready within the next few months. Are we going to call it FIRESCOPE EMT, since we do not have the ICS designation?

Fire Line EMT- It may need to be a full course instead of just a job aid. Some of the personnel who are coming through the ranks have never had Fire Line EMT training. Most metropolitan firefighters are working independently and are not thinking wildland; they need to have skills to adjust to wildland environments. Their roles have never been clearly defined.

The Fire Line EMT must be able to build a rapport with the contract crews who are afraid of reporting injuries, especially when working with the federal Type II crews. Some of these crews have culture differences and hide their injuries. This is

prevalent with national crews like the Pacific Island crews, the Alaskan Crews and the BIA Crews. These groups traditionally hide their injuries. The Fire Line EMT's job is to build a rapport so that these groups come to them with their problems to prevent serious injuries.

Course should be all inclusive of what's needed for all the situations they may face, whether it is an 8 or a 16 -18 hour course, a legal component may need to be added.

Bill will meet with Mike Colgan and see what the true issues are. There is already an environmental rehab and we must be careful not to cross over into that area.

## (WATERSHED) MULTIPLE USES

Using the term <u>Environmental</u> Rehab is going to get bigger. Using the term environmental rehab, may make it more acceptable, within a big fire camp. How can you direct the people to rehab?

## AREA COMMAND AND EOC

Is this an agency-specific issue? Can they really say that an area command can never be co-located with an EOC? In the Area Command Book- Module 15, it states that the area command may be co-located with the EOC. In small jurisdictions, the fire chief may be the EOC director/manager. In small communities, this may be the norm. Chief Neamy thinks they should be located in separate locations. Alteration of this component would affect the smaller communities negatively. It has to be allrisk and all type of model.

## EMERGENCY MEDICAL SERVICE AGENCY

We need to recommend someone from FIRESCOPE for this review committee who know ICS Mutual Aid experience and who can speak EMS. Neil has been assigned to this committee currently, he seems to be well versed on the issue. We do not have an additional name to submit.

The issue addresses the issue that an ambulance is not an ambulance, they need to be typed for a medical skills, not just for transportation ability.

Ambulance Strike Teams crossing into different counties may not be able to treat from one county to another. The county health doctor will dictate what type of treatment will be permitted. These are some of the issues that must be addressed immediately. How are they going to be used? What are they going to be allowed to do, who will restock them?



#### **Round Table**

**Marv Moneymake**r– We have14 new recruits from the academy but we are still short paramedic positions. If you know any one interested, please have them contact our human resource person Carol Patrick - <u>carolpatrick@sbcfire.com</u> for recommendations for paramedic position. Received our new E1 and it is in service, hundred-foot truck/tiller. Andy Rosenberger will have hip replacement surgery in June.

**Greg West** – Mayors budget was released and fire was better off than law enforcement, an increase of 5%. LA City will be adding a Haze Mat squad to the harbor area, ten ambulances, and will be adding a Battalion Chief to the terrorism early warning group that LA County runs. In addition, we will be adding an Assistant Chief position in Risk Management. We have replenished our paramedic personnel. San Fernando Valley seccession will make LA the third largest settind Chicago, and make San Fernando sixth largest city. Has potential to make a great impact on how LA is structured. IF ITIS SUCCESSEVE,

**Bill Plough** – Southern Region fire season is in gear, CDF have brought on to Art /2 Attacks. Most of the Southern Region will be open fire season in the next few. The tanker base at Ramona has shut down for runway repairs, and has been relocated to Gillespie Field in San Diego. Budget is a big issue with a 20 million dollars budget reduction. The cuts will have to come from the heart of operation like engines and crews. The contract counties may have to pick up the heat. The Department of Finance has to will have to have direction directly out of the Governors' office. CDF no longer controls the E-Fund, we have to go directly to the Department of Finance.

**Tim Fike** – Moving slowly towards more consolidation, currently four to date over a five-year period. We have set up training for fire through Sierra College at the fire stations (420). We are incorporating the fire stations as a satellite location with the college for training.

**Steve Hutchinson** – Budgets are also an issue for State Fire Marshal. Many departments are having money issue and not are able to send personnel to class. The instructor 1A and 1B training has been taken off the shelf, making the course a 10-day class. The instructor II series is changing, and the instructor III series will be for new training officers to help reduce the class requirements. The Command 1C course has already mapped, and will be piloted by December 2002. A state committee has accepted large animal rescue course. Many states are waiting for California to adopt this course then they will adopt is also. Not out yet due to some copyright issues. Driver Operator 1A and 1B, hope to be complete and out by June 2002.

**Hal Chase** – Santa Clara County is finalizing their hunt for new fire chief. First round of interviews is complete. Only one person from within Santa Clara County has applied. Those in the final group will be invited for an all day session on Monday. We have 16 people in our fire academy currently. Our 3% at 50 will start

next month, and we expect many new retirees in the next couple of years. Santa Clara County took delivery of a new type  $\mathbb{II}$ , 75 ft aerial. No money problems as of yet, overtime is high due to personnel shortage.  $\mathcal{I}$  ENG  $\mathbb{II}$ , 3 TYPE ONES

Alton McMillon – Sacramento City just had the dedication of the Fire Fighter Memorial. Sacramento will be experience budget problems also, expecting the state to shift their shortage of funds in there direction. We have received the first three new engines of 11 that are coming in for training. New station will be built in old location. Two academies under way, our first lateral engine academy is underway with 10 total. FDIC west will start next week. There will be hands on instruction and hands on drills, with burns and extrication, excellent training.

**Mike LaPlant** - Ventura has an academy starting in September. We will start dispatching for Santa Paula City fire in July. The community college district just got a 325-Million dollar bound passed. Make Camarillo center as a training location to make it a joint county fire and law enforcement. Our training is expanding; this will mean more medics they are still hard to find. Will start a lot of MCI training to include this will include battalion chief and ambulance supervisors chiefs. Our goal is to get them talking ICS.
