S-341 class – Chris W., Lorri P-L, Rich S. – the need for having this class in 2013. The GACC training officers are not planning on having this class in CA next year. The original plan was to have this in southern CA for 2013. Recommendation is to poll the field to see if there is sufficient interest to hold the class. Open discussion – CA no travel out of state, local government, the perceived need to get this class to other locations outside of GACC, students in the class are from a diverse group, many from command centers, there are many trainees that have not gone out yet, this year could be different, now is the time for the state folks to plan for training, **ACTION ITEM** – Chris W will put together a request and when ready will share it – Feb/Mar

S-341 Class – Updated curriculum materials. Is Emmor updating this? Are these done? What about reviews? Lorri will contact Don about this. Rich is reaching out to Emmor to see if this is done.

Intermediate GISS Training – Rich – pushing CAL FIRE to have an intermediate GISS training in April of this spring – currently working on the first or third week of April. Nothing is firm at this time – just in planning stages and funding issues. Past training sessions have been 25-40 students.
